**ORDER OF APPOINTMENT OF COUNSEL
TO THE FORT MYERS DIVISION CJA PANEL**

Section 1.04(c)(2) of the Criminal Justice Act (CJA) Plan for the Middle District of Florida, issued by the Honorable Patricia C. Fawsett, Chief United States District Judge, on April 30, 2004, and approved by the Judicial Council of the United States, Eleventh Judicial Circuit, on July 6, 2004, provides for panel attorneys to meet certain minimum qualification standards. The attorney listed below is found to have satisfied these standards.

Accordingly, it is hereby

ORDERED that the attorney listed below is appointed to the CJA Panel, Fort Myers Division, for the current three-year term of July 1, 2003, through and including June 30, 2006.

IT IS FURTHER ORDERED that during this three-year term, the named CJA Panel Member will attend and complete at least one continuing legal education program annually. The program must emphasize federal sentencing

guidelines and other aspects of federal criminal trial practice approved by the FPD for the Middle District of Florida. The Panel Member must provide the FPD with written evidence of attendance or participation in such training course/seminar in the manner specified by the FPD.

After the three-year term of service on the CJA Panel, the Panel Member may reapply and be reappointed for succeeding three-year terms, provided the Panel Member continues to meet the qualifications standards set forth in section 1.04(c)(2) of the CJA Plan for the Middle District of Florida.

Each Panel Member must register on the website for the United States District Court, for the Middle District of Florida, at www.flmd.uscourts.gov to obtain an ECF login and password *and* must register on the PACER website at www.pacer.psc.uscourts.gov to obtain a PACER login and password.

The following attorney has met the qualification standards for the current three-year term:


