
completing of their minimum educational requirements, as certified by the Office of the Federal Public Defender, MDFL.

IT IS FURTHER ORDERED that the attorneys listed shall remain in compliance with the requirements of the CJA Plan for the Middle District of Florida and shall remain in good standing with The Florida Bar and the Bar of this Court. A panel attorney who fails to maintain the annual Bar dues of this Court or the minimum educational requirements, as required by the local rules and the CJA plan, shall be removed from the panel list and ineligible for further appointment until the attorney satisfies the bar dues and educational requirements.
