COMES NOW, the accused, SAMI AMIN AL-ARIAN, by and through his undersigned counsel, and moves this Honorable Court for the entry of an Order allowing a contact visit with his wife, **Nahla** Al-Arian, and his children, and as grounds therefore would state:


1. The Accused is a pre-trial **detainee** in Hillsborough County Jail.
2. The Accused is not allowed **any** contact visits with any member of his family absent a Court Order.
3. From February 1, 2004 **through** February 4, 2004, the second holiest holiday of the Muslim **calendar**, which comes after the Pilgrimage Season (the Hajj) is **celebrated**. It is called the Feast of Sacrifice.
4. This is a time that **millions of Muslims** around the world traditionally celebrate and one that Dr. **Al-Arian** would like to share with his family.
