ORDER

THIS CAUSE is before the court *sua sponte*. In the near future, Defendants Al-Arian and Hammoudeh will be transported from FCI Coleman to Hillsborough County for a period of time to permit their review of discovery in this cause. At present, the Defendants are in possession of certain "tech cut" summaries pertaining to translations and comments made by FISA interpreters who reviewed intercepted communications in this investigation. The Defendants seek permission to bring this discovery material with them while they are in Tampa to permit their continued review. The court considers this *ore tenus* request as a motion and the motion is hereby **GRANTED**. Authorities at FCI Coleman shall permit these documents to be delivered to the United States Marshal for transport, along with these Defendants, to Hillsborough County. Authorities at the Hillsborough County jail shall permit the Defendants to have such discovery material in their cell for their continued review. Upon the Defendants' return to FCI Coleman, such material shall be returned with them by the United States Marshal.
