MOTION FOR APPROPRIATION OF FUNDS TO  
FACILITATE DUPLICATION OF DISCOVERY AUDIO TAPES

The Defendant, SAMI AL-ARIAN, hereby moves that the Court enter an Order appropriating funds to facilitate the duplication of discovery audio tapes and in support thereof, states:

1. Undersigned counsel has been appointed to represent defendant, SAMI AL-ARIAN pursuant to the Criminal Justice Act. The defendant has been found to be indigent.

2. The Government has indicated that it will produce a copy of approximately 200 intercepted communications which have been reduced to separate cassette tapes as to each communication.

3. In order to facilitate delivery of a copy of the tapes to defendant AL-ARIAN, the Federal Bureau of Investigation has indicated that it would obtain a complete set of the cassette tapes by way of commercial duplication if the costs were borne

by the defendant. The FBI would then directly forward the duplicate copy of the cassette tapes to FCC Coleman in order that the tapes may be made available for review by Defendants AL-ARIAN and HAMMOUDEH.

4. The defendant is unable to pay costs of duplicating the cassette tapes.

WHEREFORE, the Defendant prays that the Court will enter an Order authorizing payment under the Criminal Justice Act for the duplication of discovery cassette tapes.


