Filing fee for opening civil action (Effective 5/1/13-this includes a \$50 Administrative Fee for Filing a Civil Action, Suit or Proceeding in a District Court. This fee does not apply to applications for a writ of <i>habeas corpus</i> or to persons granted <i>in forma pauperis</i> status under 28 U.S.C. § 1915.)	\$400.00

*Actions brought under Title III of the Cuban Liberty and Democratic Solidarity (LIBERTAD) Act of 1996, P.L. 104-114, 110 Stat. 785 (1996) (This fee is in addition to the filing fee prescribed in 28 U.S.C. § 1914(a) for instituting any civil action other than a writ of habeas corpus.)	\$6,548.00

*Miscellaneous filings - Filing or indexing any document not in a local case or proceeding for which a filing fee has been paid, including registration of a Foreign Judgment or a Judgment from another district.	\$47.00

This fee shall apply to services rendered on behalf of the United States, if the information requested is available through electronic access. Copy Fees - Reproduction per page of any record or paper (fee assessed in addition to certification fees). This fee shall apply to services rendered on behalf of the United States, if the record or paper requested is available through electronic access.	\$0.50
Electronic Copy Fees - Copy of an imaged page printed from public access terminal. (Docket information for all active and some closed cases is available through electronic access. See "Electronic Access" on page three.)	\$0.10
*Fee for reproduction of recordings of proceedings regardless of medium. This fee shall apply to services rendered on behalf of the United States, if the reproduction of the recording is available electronically.	\$31.00
Archived Record Retrieval Fee - For retrieval of each case record from the Federal Records Center, National Archives, or other storage location removed from the place of business of the court.	\$64.00 for 1 <sup>st</sup> box; retrievals involving

Registration of Power of Attorney (31 U.S.C. § 9306(b) requires surety corporations to file a certified copy of the power of attorney for each location at which the court sits.	\$230.00
