ORDER

Before the Court is the parties Joint Unopposed Motion to Bring Laptops into the Courtroom at Status Conference and Future Hearings and the Joint Unopposed Motion for Telephonic Access at Future Status Conferences and

- 1. The parties' Joint Unopposed Motion to Bring Laptops into the Courtroom at Status Conference and Future Hearings (<u>Doc. 41</u>) and the Joint Unopposed Motion for Telephonic Access at Future Status Conferences and Hearings (<u>Doc. 42</u>) are **GRANTED**¹.
